This report covers the first quarter of 2020. During this period, DG MARE and EMODnet Secretariat undertook a performance assessment of the Chemistry data portal. The Coordinators were invited to a number of web meetings with EU and Secretariat at 31/1/2020, 14/2/2020, 6/3/2020, and 13/3/2020 to discuss these. EMODnet Chemistry replied, providing technical details and a document with a specific scheduling for fixing all issues as highlighted in the monitoring and assessment summary delivered by EMODnet Secretariat. The document of EMODnet Chemistry received further comments and recommendations from the Secretariat and these are taken into account by EMODnet Chemistry in its actions for improving the portal. Concerns were mainly addressed to EMODnet Chemistry portal, being not clear in the objectives and not services oriented, as well as to the viewing and access services. Therefore, ongoing actions are dedicated to reshuffling the site map of the EMODnet Chemistry portal, simplifying the homepage, **placing the products for specific chemical substances and their services more centrally as major output**, and further integrating the different services for access, viewing, and downloading aggregated data collections and maps, by GUIs and OGC web services.

In parallel, EMODnet Chemistry partnership actively engaged its main stakeholders with videoconference meetings, discussing progress of activities for the current contract as well as brainstorming about the future perspective of EMODnet as published by the EU. There was a Chemistry Project Group web meeting held at 11 and 12 March 2020. Following the **EEA** request, an interim harvesting was done in January 2020 on eutrophication and will be done in April 2020 on contaminants in order to produce and to deliver regional QC datasets for eutrophication and contaminants by end May 2020 to EEA. A joint EMODnet Chemistry - **CMEMS INSTAC** meeting was held on 12-13 February 2020, to share expertise and biogeochemical data, to plan joint products and solve metadata issues. As follow-up to the proposal for a joint EMODnet-Copernicus MSFD portfolio (presented at the Copernicus Marine for MSFD workshop, Brussels, 2nd October, 2019), the 1st draft has been prepared and will be shown by Mercator at the next annual meeting in April, 2020. EMODnet Chemistry as member of **TG ML**, continued to act as European data portal for Marine Litter (gathering data from MS through its NODCs). Thanks to this positive interaction, EMODnet Chemistry has been asked by JRC and EEA to aspire such a central role as European data portal also for Contaminants, gathering data input from MS.

In the following the highlights for the period January - March 2020 are outlined for each of the tasks specified in Section 1.4.1 of the Tender Specifications:

Task 1: Develop a common method of access to data held in repositories:

- Raw chemistry data sets for eutrophication, ocean acidity, contaminants and marine macro litter are gathered from many data sources and are findable, accessible, interoperable and reusable thanks to the adoption by EMODnet Chemistry of the SeaDataNet Common Data Index (CDI) data discovery and access service. While marine litter data for beach litter and seafloor litter, also coming from different sources, are managed in two central databases, involving a lot of efforts for validation, classification, and metadata documenting. Due to the high heterogeneity of the source data, dedicated data formats have been developed and deployed, able to hold all needed metadata and data elements. The

gathering is a continuous process while at specific instances, raw chemistry data sets are harvested and thereafter analysed, quality controlled and aggregated into harmonized and validated data collections for eutrophication, contaminants and marine litter. These are then made accessible as major products of EMODnet Chemistry for viewing and downloading at the EMODnet portal, supported by metadata. The data gathering activities are continuous while in the reporting period additional activities were dedicated to exploring options for handling marine micro litter in a comparable way and how to enrich metadata with additional info on project type, platform, and regions.

Task 2: Construct products from one or more data sources that provide users with information about the distribution of parameters in time and space:

- Aggregated data collections are produced for eutrophication and contaminants, interpolated basin maps are produced for selected eutrophication parameters, while dedicated maps are produced for marine litter. All products can be viewed and interrogated in the OceanBrowser service and are described in the Sextant product catalogue. For eutrophication also maps are included displaying the distribution of data locations, and giving information on the number of observations related to a single parameter (e.g. water body pH map). By clicking on the dots representing the sampling stations, access is given to time series or vertical profiles. In the reporting period, efforts were aimed at loading the latest eutrophication data collection in the EMODnet Chemistry database and improving the integration with the OceanBrowser to optimise the viewing and access functionality. Moreover, activities were undertaken by the Regional Coordinators for processing the latest eutrophication harvest in response to the interim request by EEA, while processing of contaminants will follow in April – May 2020. For the latter, activities took place for improving data sets with known issues in preparation of a new harvest of contaminants data. Moreover, attention was given to improving the workflow for analysis, handling, and publishing of contaminants data collections, and derived maps.

Task 3: Develop procedures for machine-to-machine connections to data and data products:

- Machine-to-machine connections to data and data products are upgraded following the [Technical Guidance for the implementation of INSPIRE View Services](#). EMODnet Chemistry products catalogue provides the INSPIRE metadata fields requested for enabling machine-to-machine connections, by including information on OGS services and data URL. The [INSPIRE validator tool](#) is used for validating the service. All MetadataURL point to standard XML and to a human readable text.

Task 4: Develop a web portal allowing users to find, visualise and download data:

- The EMODnet Chemistry portal is under review and restyling following the observations received from EMODnet Secretariat. In the new set-up, the section DATA will provide quick and easy access to the harmonized and validated data collections which can be downloaded in ODV csv file, while additional export formats and subsetting functionality are considered to make access easier for users; the section PRODUCTS will allow the user to browse, visualise and download data products. News and events are continuously updated (two additions for the period). In the reporting period, a Technical Working Group web meeting took place at 10 March 2020 to discuss the new portal set-up, the further integration and well-functioning of all services, establishing a common downloading mechanism for all different products, and solving the INSPIRE compliance requirements.

Task 5: Ensure the involvement of regional sea conventions:

- Dialogue with four Regional Sea Conventions has been maintained through the participation in the MSFD Technical Groups (on Data and Marine Litter), where a regular dialogue is established, and through the MSFD Board of experts, consulted prior to the release of new products. RSCs expressed interest to be part of the Advisory Forum.

Task 6: Facilitate interoperability with data distributed by non-EU organisations:

- EMODnet Chemistry started contacts to set data sharing with WOD, beginning with oxygen data. As EMODnet Chemistry builds upon the SeaDataNet pan-European infrastructure, it has strategic links and long-standing communication with non-EU countries and in particular with Australia, Canada, and USA. EMODnet Chemistry vocabularies and metadata directories are also adopted by non-EU organisation, enabling interoperability and data sharing.

Task 7: Install a process to monitor performance and deal with user feedback:

- Procedures are up and running. COVID-19 emergency did not affected the functionality. No new progress to report.

Task 8: Operate a help desk offering support to users:

- The helpdesk is kept operational in the reporting period. COVID-19 emergency did not affected the functionality. All support requests received via the Help desk are listed in Section 4.

Progress indicator	Comment
1.1 Volume and coverage of all available acquired data	EMODnet Chemistry data volume is very high and this reduces the trend values calculated as growth rate $\left(\frac{\text{ACTUAL}-\text{LAST}}{\text{LAST}}\right)*100$. A positive increase is present for all subthemes, with the only exception of Marine Litter for a major revision by ICES of Seafloor DATRAS data. The corrected datasets are expected in the upcoming quarter.
1.2 Total number and the coverage of all built & external data products	Data products are available for all subthemes. Eutrophication shows higher numbers due to different seasons (4), sea basins (6) and additional layers produced by DIVA software. Marine Litter subtheme is more heterogeneous.
2. Overview of all organisations supplying and approached to supply data and data products within reporting period	66 Data providers are listed, with related contributions. Numbers are stable.
3. Interfaces to access or view data	All interfaces available are listed.

Usage of data and data products per interface and per theme	There is a big increase in map visualisations of marine litter; contaminants map visualisations number is quite high compared to other subthemes. As discussed earlier with Secretariat it is not possible to monitor and report data volumes for CDIs. For Data Products we are developing a web service which will help providing these numbers

The monitoring numbers reported as part of the progress monitoring of EMODnet performance are collected through Matomo. Therefore, results are indicative and care should be taken with interpreting absolute numbers or comparing results from different tools.
