1. Highlights in this quarter

Task 1: Maintain and improve a common method of access to data held in repositories

Task 2: Construct products from one or more data sources that provide users with information about the distribution and quality of parameters in time and space

- AIS data acquired for 2022. Vessel density maps are being processed as usual. They're being added to the database, as shown in the statistics.
- Route density maps updated to February 2023

Task 3: Develop procedures for machine-to-machine connections to data and data products

Task 4: Contribute data, data products and content to a central portal that allows users to find, view and download data and data products

Updated data sets:

- Oil & gas wells
- Oil & gas licences
- Algae production sites
- MSP (Netherlands now added)

Research for possible new data products related to <u>cultural heritage</u>, based on data sent through Data Ingestion Services by the Irish Marine Institute, in particular the World Heritage List of the UNESCO. The work focused on how to single out sites of coastal interest. In particular, there are two approaches that are being evaluated:

- 1. Using Eurostat's definition of coastal areas: municipalities (around 12% of municipalities, typically LAU2) that border the sea or that have 50% of their surface within a distance of 10k from the sea.
- 2. Using Eurostat's definition of coastal regions: regions (NUTS-3) that either have a sea border or have more than half of their population within 50 km from the sea.

Research and data processing for new shellfish data products, as per a recommendation from the Aquaculture Advisory Council to DG MARE:

- Polygons for farms (FR, IE and ES);
- Areas classified from a health point of view under the Hygiene Package (Regulation (EC) No 854/2004) (replaced by Reg. 2017/625) (FR and IE)
- Areas designated under the Water Framework Directive 2000/60/EC for the protection of economically significant aquaculture species (IE and Scotland).

Task 5: Contribute content to dedicated spaces in the Central Portal



Method for vessel density maps is being transposed to the EC template so to get a DOI from the EU Publication Office. As the method is cited extensively in literature, having a DOI will make it easier to track citations.

Task 6: Ensure the involvement of Regional Sea Conventions

Still trying to schedule interviews with RSCs. Overall this is not a major impediment, as yearly interviews are probably not necessary.

Task 7: Contribute to the implementation of EU legislation and broader initiative for open data

Task 8: Monitoring quality / performance and deal with user feedback

Task 9: Maintain the existing thematic web portal for a maximum of six months from the start of the project

Portal now fully phased out. A non-accessible version is being maintained just in case.
