

This new EMODnet service provides the highest resolved topographic and bathymetric worldwide layout currently available with land and sea integration matching the OpenStreetMap coastline representation.


EMODnet: A decade of achievements connecting marine data to knowledge

EMODnet Human Activities maps illustrate how COVID-19 is affecting the Blue Economy and the marine environment



It is often said that a picture is worth a thousand words. Over the past few weeks, with the COVID-19 crisis, we've grown accustomed to seeing pictures of the most iconic places in our big cities – the same places that not long ago would be bristling with life – now looking in all their majestic emptiness as glimpses of a post-apocalyptic future. We haven't seen many pictures of the impact of the virus on our seas, though.

The EMODnet digital vessel density maps, released in March 2019, allows users to visualise vessel movement patterns and the distribution of maritime traffic in European waters. The maps on fishing vessel density illustrate astoundingly how

the fisheries sector has been struggling during this pandemic with visible reduced activity.

The first meeting of the EU4Ocean Platform – the recently established EC hub to connect stakeholders that contribute to ocean literacy and the sustainable management of the ocean - took place on the 18 June 2020. More than 90 participants joined the discussions from all over Europe, representing a diverse spectrum of marine, maritime (science, policy, industry, civil society, outreach) and wider ocean literacy, education, youth and media representatives.

The European Atlas of the Seas, for which EMODnet is the main data provider, was presented as a key resource for ocean literacy activities. Best practices on data sharing under the current pandemic

In order to help researchers, policy makers, funders, publishers, and providers of data sharing infrastructures maximise the timely sharing of quality data and appropriate responses to health emergencies, particularly COVID-19, the



Research Data Alliance (RDA), commissioned by the European Commission, published a pre-final version of recommendations and guidelines covering four research areas - clinical data, omics data, epidemiological data and data from the social sciences and humanities.

During this pandemic, the timely and accurate collection, reporting and sharing of data with the research community and policy makers has shown to be critically important. Research results, data, and information needs to be accessible to the public to the greatest extent possible. There is a strong support for recognizing open research data as a key component of preparedness and response.
