1. Highlights in this reporting period

These two months were mainly devoted to the data portal and project website opening which took place just before Christmas. Moreover, the past experiences surveys have been finalized and the one concerning economical models and governance of data has been filled in by all the partners.

The first version of the portal and of the project website has been finalized during the period running up to the portal meeting (1-2 December). Its implementation has been completed during December and the portal was publicly opened on 23 December. Data initialization will be constantly developed all throughout the project; however some datasets are already available on the portal.

The survey elaborated in order to list and summarize past experiences in terms of coastal mapping was validated on 22 December, and has to be filled in by the partners and other major maritime stakeholders by end of January 2016. The results of the survey will be used to develop an algorithm in order to improve the coast survey planning at regional and transnational level (Coastal Mapping Planner – CMP). Concerning the CMP, the basic concepts have been elaborated (decision tree using fuzzy logic).

Another survey concerning economical models and governance of data has been finalized on 9 November. The first results were presented at the portal meeting. Some other tasks have made significant progress during this period : Inventory of the used vertical references, study on sharing platforms, analysis of the current EU fundings and identification of tools for the validation of the future programme.

The coordinator participated in the 5th EMODnet Steering Committee meeting (9-10 December). The project team was represented in the EMODnet-INSPIRE Technical Workshop (7-8 December) and in the EMODnet MSFD coordination meeting (8-9 December).

The consortium agreement is now signed by all the partners. Regarding the withdrawal of one of the initial partners as was mentionned in the previous progress report, an official amendment request is in preparation by the coordinator.



2. Specific challenges or difficulties encountered during the reporting period

The project officially started just before the summer period, during June that was a very busy month for all the partners (Service Contract signature on 26 June 2015). This caused difficulties to get feedback from the partners on the Consortium Agreement draft and to finalize it before early October (final version dated 9 October). The Consortium Agreement was finally signed by the last partner on 26 November.

The first most critical issue was the opening of the portal (WP1) before Christmas. As the specifications were validated during the Ostende meeting (period 2) and the portal meeting raised no critical issue, the portal got opened in time. ETRS-LAEA (EPSG:3035) was finally preferred to the other projections even if the other EMODnet portals do not use it, but the portal allows the re-projection with WGS84 (EPSG:4326) and WGS84 Web Mercator (EPSG:3857).

The second most critical issue is the production of the algorithm (WP2) which must be defined before end of March 2016, but several other actions related to the WP2 and WP3 are also in progress and even if they are under specific supervision by different partners, they need inputs from almost all of the partnership in a very short time (several actions must be finished before the end of March 2016 (Interim report).
