1. Highlights in this quarter

Task 1: Maintain and improve a common method of access to data held in repositories

The following data sets received an update:

- Dredging
- Nationally designated areas, polygons
- State of bathing waters
- Fishing quotas by FMZs (attributes updated)
- MSP zoning element, polygons

In addition the marine finfish dataset has been fully updated but has not yet been uploaded online. It will be made available in the coming days. It includes updated data from Cyprus, Denmark, Estonia, Greece, Ireland, Malta, Norway, Spain (not downloadable) and the United Kingdom. The farm typology used for the symbology was also revised to improve consistence in the level of details of the different categories and provide a better coverage. The new farm typology includes the following farm types: Flatfish, Salmonids, Seabass-seabream and other coastal fish, Tuna, Other.

Continuous desk research for potential new sources is carried out. In France the new Geolittoral GIS website should allow to significantly improve the coverage for the next update of the shellfish dataset. Additional registration data was also found in Romania, but without geographical coordinates. in Slovenia, coordinates corresponded to the location of the companies and not of the sea cages, and therefore were not included in the marine dataset, but this source will be useful for the freshwater aquaculture dataset.

One new data set was completed, though it will be made available on the map viewer over the coming days:

- Nationally designated areas, points: this dataset provides the location of nationally designated areas where polygon data is unavailable.
